



## LIFE MEMBER NOMINATION FORM

The IRMTNZ values the knowledge and experience of its members.

Life Membership celebrates and recognises the contribution of registered members whose loyal and outstanding service has provided a measurable benefit to IRMTNZ. Nomination as a Life Member requires the member to have given extensive and exceptional service to IRMTNZ and the music teaching profession, as outlined in the criteria below, and be approved by Council as having satisfied these criteria. Any nomination for Life Membership that is approved by Council will then be presented for election as a Life Member by at least three quarters of those present at any general meeting of the Institute.

### Criteria

The criteria for consideration as a Life Member of IRMTNZ is *extensive and exceptional service to the Institute and the music teaching profession*. Specific examples are:

- membership of IRMTNZ of at least 25 years.
- shares knowledge and experience to benefit other music teachers, reflecting the goals and aims of IRMTNZ.
- has contributed regularly to local, branch and national IRMTNZ events and publications.
- is widely regarded as advocating for music teaching in Aotearoa New Zealand, across all education sectors, reflecting the goals and aims of IRMTNZ.
- has made a significant contribution to music education locally and/or nationally.
- has brought public honour and distinction to the music profession.
- has made significant contribution to young musicians at a national and/or international level.

This form is for nomination of a member for consideration as a Life Member. The nominators (who must be registered and current financial members of IRMTNZ) will need to:

- i) attach a brief citation for the nominated candidate outlining why they believe this candidate should be considered for such an honour AND
  - ii) complete the attached document to provide evidence of each criteria outlined above.
